



Government Affairs Award

The NARI Government Affairs Award is presented to a NARI member or members who have demonstrated active involvement in pursuing the legislative interests of the professional remodeling industry. Entrants may be active on any or all levels of government including federal, state, county and city.

Submission Requirements

In order to be considered, you must submit a complete set of the following documents:

1. An explanation of the issue encountered, allies, opposition forces and outcome.
2. A summary addressing each of the judging criteria listed on page three (not to exceed 3 single-spaced pages).
3. A description of the resources devoted to the issue campaign or government relations program (i.e. time, money, human resources, etc.)
4. A copy of any materials developed and used during the legislative program (i.e. briefing papers, testimony, press releases, flyers, etc.).

All entries must illustrate government affairs activities that have occurred between December 1, 2009 and November 30, 2010.

Judging Criteria

Each entry will be reviewed according to the criteria outlined below. Applicants should demonstrate their involvement in the following activities:

- Monitoring and tracking legislative activities
- Coordinating communication among local associations
- Setting legislative goals and establishing a consensus among local associations
- Promoting the legislative interests of the professional remodeling industry
- Initiating press releases concerning NARI legislative activities and goals
- Building coalitions with similarly aligned organizations to achieve NARI legislative goals
- Regular contact with legislators espousing NARI positions (i.e. phone calls, letters, personal visits, testimony, draft language, etc.)
- Regular contact with NARI Government Affairs Department regarding pending legislation, position statements, strategy and tactics
