- Most NARI Chapter educational events qualify as NARI CEUs.
- Teaching a program that qualifies for NARI CEU or a NARI Certification Study Group qualifies for CEUs

What does not qualify for CEUs?

- Any program that promotes a product or service (*as a sales pitch*) will not be approved for CEUs.
